25-Year Limited Residential Warranty

Coverage

TimberTech FenceScape (hereinafter "FenceScape") warrants to the original consumer purchaser ("Purchaser") that, for a period of twenty-five (25) years from the date of original consumer purchase, under normal use and service conditions, FenceScape products shall be free from material defects in workmanship and materials, and shall not check, split, splinter, rot or suffer structural damage from termites or fungal decay.

If a defect appears within twenty-five (25) years from the date of original customer purchase, Purchaser shall notify FenceScape in writing within thirty (30) days from the discovery of the alleged defect, and, upon confirmation by an authorized FenceScape representative of the defect, FenceScape's sole responsibility shall be, at its option, to either replace the defective item or refund the portion of the purchase price paid by Purchaser for such defective item (not including the cost of its initial installation). This warranty shall not cover and FenceScape shall not be responsible for costs and expenses incurred with respect to the removal of defective FenceScape products or the installation of replacement materials, including but not limited to, labor and freight. The foregoing remedies are the SOLE AND EXCLUSIVE REMEDY FOR BREACH OF ANY WARRANTY.

Transferability

This warranty may be transferred one (1) time, within the five (5) year period beginning from the date of original purchase by the Purchaser, to a subsequent buyer of the property upon which the FenceScape products were originally installed.

To Make a Claim

To make a claim under this limited warranty, Purchaser, or the transferee, shall send to FenceScape, within the warranty period referred to above, a description of the claimed defect and proof of purchase, to the following address:

Each Purchaser is solely responsible for determining the effectiveness, fitness, suitability and safety of the FenceScape products in connection with its use in any particular application.

No person or entity is authorized by FenceScape to make any statement or representation as to the quality or performance of FenceScape products other than as contained in this warranty, nor is FenceScape bound by any such statement or representation. This warranty may not be altered or amended except in a written instrument signed by FenceScape and Purchaser.
